Carbon Reduction Projects

The following environmental management measures and projects are currently in progress or have been completed since the 2025 baseline.

Actions In Progress

Reduce business car travel through smarter planning

Target Completion Date: 31/12/2027

Objective

To reduce emissions from business car travel by improving journey planning and promoting lower carbon alternatives.

Target

Achieve a measurable reduction in business car mileage by encouraging meeting stacking, increased use of online meetings, and more efficient travel planning.

Action, Improvement or Control

Staff will be encouraged to reduce unnecessary car journeys by combining multiple meetings into a single trip where practical. Employees will be supported to use online meetings instead of travelling when face to face attendance is not essential. Forward planning of appointments will be promoted to minimise repeat journeys and consideration of public transport will be encouraged where suitable.

Expand the scope of the emissions calculated

Target Completion Date: 31/12/2027

Objective

Capture more accurately all relevant emissions data to reflect all of the organisations activities

Target

To include all relevant scope 3 categories and extend boundary from UK to global

Action, Improvement or Control

Revise data-collection protocols to capture finer metrics, involve and engage all relevant suppliers and activities across the 15 categories

Appoint a Sustainability Champion

Target Completion Date: 31/12/2027

Objective

To designate a Sustainability Champion responsible for coordinating, monitoring, and supporting all emissions-reduction activities across the organisation.

Target

Appoint a named Sustainability Champion with clear responsibilities, ensuring consistent oversight of carbon-reduction projects and regular communication across the business.

Action, Improvement or Control

We will appoint a Sustainability Champion from within the organisation to act as the central point of contact for sustainability matters. They will monitor progress against emissions-reduction actions, identify any barriers to delivery, and help ensure activities remain on schedule. The Sustainability Champion will also promote engagement by sharing updates with staff and encouraging good practice across departments.

Enhance Emissions Data Granularity

Target Completion Date: 31/12/2027

Objective

Improve the precision of our carbon reporting by capturing more detailed activity data across all emission sources.

Target

Ensure that all significant emission sources are monitored with sufficiently granular data to support accurate calculations

Action, Improvement or Control

Revise data collection protocols to include finer metrics (e.g. fuel type, distance, consumption rate)
